

1800mattress.com “Ratings & Reviews” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING.

DATES OF PROMOTION: The “Ratings & Reviews” Sweepstakes (the “Sweepstakes”) begins at 12:00 a.m. Eastern Time (“ET”) on March 23 2012 and ends at 11:59 p.m. ET on September 23, 2012 (the “Sweepstakes Period”). All entrants must have access to the Internet in order to participate in this Sweepstakes. Normal Internet, phone and usage charges imposed by your online or phone service may apply.

ELIGIBILITY: In order to be eligible for entry into the Sweepstakes, you must be a legal permanent United States resident residing in the 50 United States or the District of Columbia and 18 years of age or older with a unique valid Social Security number at the time of entry. Employees and their immediate family members (parents, children, siblings or spouse, regardless of where they live, or persons living in same household, whether related or not) of 1800mattress.com (the “Sponsor”) its subsidiaries, and each of their respective parent companies, franchisees, affiliates, contractors, consultants, legal counsel, public relations, subsidiaries, distributors, sales representatives, retailers, website providers, webmasters, advertising and promotional, fulfillment, and marketing agencies, and any others engaged in the development, production, execution or distribution of this Sweepstakes, herein (the “Sweepstakes Entities”), are not eligible to participate. HOW TO ENTER: There are two (2) ways to enter:

1. ONLINE: Visit www.1800mattress.com (the “Website”) during the Sweepstakes Period and follow the link to the Ratings/Review Page. If you are a new customer you must register for an account in order to enter the Sweepstakes (see instructions below for New Customers). If you are a returning customer you must sign in to your account in order to enter the Sweepstakes (see instructions below for Returning Customers). Once signed in, provide a rating/review of a 1800mattress.com product in order to receive one (1) entry into the Sweepstakes. Earn one (1) entry into the Sweepstakes for each rating/review submitted during the Sweepstakes Period. All ratings/reviews will pass through a quality control check by Sponsor in order to be eligible for entry into the Sweepstakes. In order for an entry to be valid, entrant must have a valid account with 1800mattress.com and their rating/review must pass the Sponsor’s quality control check. All entries must be

submitted by 11:59 pm ET on September 23, 2012. You must complete all required information to be eligible to enter to win a prize. Entries having incomplete information will be disqualified and ineligible to win.

New Customers: To Create an Account, visit the Website during the Sweepstakes Period and click on Create an Account or Sign in. Then complete the New Customer information and click continue to register your information including your first name, last name, address, city, state, zip code, e-mail address, and Home phone number (including area code). Then, hit continue in order to complete your registration.

Returning Customers: If you are a returning customer of 1800mattress.com, submit your username and password and click continue in order to sign in to your account.

2. MAIL-IN: On a plain 3" x 5" card, legibly handprint or type your name, age, complete address, city, state, zip code, home phone number (including area code), and email address (if any). Then, mail your 3" x 5" card in a postage-affixed sealed envelope to: 1800mattress.com "Ratings & Reviews" Sweepstakes, 1000 S Oyster Bay Rd., Hicksville, NY11801. Mail-in entries must be postmarked by September 23, 2012 and received by September 30, 2012. No mechanically or programmatically reproduced entries are permitted. Each envelope is considered one (1) entry.

Regardless of the method used to enter the Sweepstakes, either via Online Entry or Mail-in or a combination of the two, the maximum number of entries allowed during the Sweepstakes is one (1) per person.

The authorized account holder is the natural person who is assigned to the account by 1800mattress.com, the organization that is responsible for assigning accounts to customers. Potential winners may be required to show proof of being the authorized account holder.

Any attempt by an entrant to obtain more than the stated number of entries by

using multiple/different email addresses, identities, registrations, logins, and/or any other methods, including, but not limited to, automated entry, will void that entrant's entries and that entrant may be disqualified from the Sweepstakes. Multiple participants are not permitted to share the same email address. Neither the Sponsor nor Sweepstakes Administrator will verify receipt of entries for entrants. All entries submitted become the sole property of Sponsor. Sponsor reserves the right to disqualify those entries deemed to be inappropriate or in violation of this Sweepstakes (as defined solely by the Sponsor).
